Since the start of the observation of Juneteenth as a federal holiday in 2021, Americans have increased their interest in narratives of emancipation. While emancipation in Galveston, Texas has inspired heightened interest, dating and experiences of transition to freedom differed based on where enslaved people resided. For this reason, emancipation is best studied at local and regional levels. This course will focus on war and emancipation in the Mississippi Valley, offering students primary documents as well as novel scholarly research from which to draw conclusions and create alternative narratives. Students will be introduced to archival research via the Internet and to African American genealogy.

Students may opt to visit Chicago's Newberry Library.
